

- An order has been passed by SAT (Securities Appellate Tribunal) Mumbai, on the 7th August 2009, in favour of the Company. On 1st September 2009, an application has been filed with the Stock Exchanges (BSE & NSE) for listing of 63,76,195 & 16,66,665 nos. of equity shares of the company allotted on preferential basis on 30th September 2008 to the promoter group companies. Pursuant to the said application Bombay Stock Exchange has approved the said listing application of 80,42,860 nos. of equity shares vide their letter no. DCS/PREF/DMN/FIP/1342/09-10 dated 27.11.2009. However, National Stock Exchange has approved for 63,76,195 nos. of equity shares vide their letter no. NSE/LIST/127734 - A dated 08.01.2010 and approval for listing of 16,66,665 nos. of equity shares is in process and expecting in due course.
- On 1st April 2009, 1,31,22,400 nos. of equity shares of Rs. 10/- each were allotted at a premium of Rs. 72.50 each on conversion of 1,31,22,400 nos. of Fully Convertible Debentures allotted to a promoter group company, M/s. Anjani Finvest Pvt. Ltd. A listing application has been filed with the Stock Exchanges (BSE & NSE) for obtaining their approval. Pursuant to the said application, Bombay Stock Exchange has approved the said listing application of 1,31,22,400 nos. of equity shares vide their letter no. DCS/PREF/DMN/FIP/1342/09-10 dated 27.11.2009. However, National Stock Exchange's approval for listing of 1,31,22,400 nos. of equity shares is in process and expecting in due course.


