1. <u>INTRODUCTION</u>

S. Kumars Nationwide Limited ("SKNL"/ the Company) is a textile company established by S. Kumars Group having its registered office in Mumbai. SKNL was incorporated as public limited company in 1990. In 1998, SKNL entered in collaboration with Reid & Taylor (International) Limited for manufacturing and marketing of suiting under the brand "Reid & Taylor" in India. It was setup as a subsidiary company under the flagship of SKNL and named as Reid & Taylor (India) Limited (RTIL). RTIL is also currently undergoing the Liquidation process.

The Company is in the business of manufacturing of cotton fabrics and has an operational weaving and processing unit at Bharuch, Gujarat, (known as High Value Fine Cotton Fabric Unit). The Bharuch unit has a capacity of manufacturing 12.50 million meters for weaving and 18 million for processing and finishing of cotton fabric annually; however, currently it is working at around 30% of its total capacity. The Company has imported plant & machinery and commissioned at Bharuch Unit under EPCG Scheme but has not fully fulfilled export obligation under the said Scheme.

On April 24, 2018, due to non-payment of debt, CIRP was initiated under IBC by the creditors of SKNL. However, as no resolution could be arrived at during the CIRP, the Hon'ble NCLT approved commencement of the Liquidation Process vide order dated June 19, 2019 and appointed Mr. Om Prakash Agrawal as Liquidator of SKNL with effect from the said date.

It is the endeavour of the Liquidator to sell the Assets and properties comprising the liquidation estate of the Company in the manner specified under Regulation 32, 33 and Schedule I (provided under Regulation 33) of the Insolvency and Bankruptcy Board of India (Liquidation Process) Regulations 2016 and other rules, regulations, orders, circulars, directions or notifications or the like, issued pursuant to or under the IBC or the Liquidation Process Regulations, as the case may be, and as per directions, if any, of the NCLT in respect of the liquidation process of the Company and in the manner specified in this E-Auction Sale Process Memorandum.
